**Mia M. Bennett** is an assistant professor of geography at the University of Washington in Seattle. She researches the geopolitics of infrastructure development in the Arctic through both fieldwork and remote sensing. She is founder and editor of a long-running blog on the Arctic, *Cryopolitics*.
